**CURRICULUM:** Legal issues of civil liability, basic emergency first aid, emergency procedures, ethics and professional conduct, patrol techniques, fire prevention and suppression, observation techniques, report writing, crowd control, traffic direction, and disaster response.

**REQUIRED TRAINING:** Per Section 493.306(5) Florida Statutes, applicants for the Class “D” Security Officer License are required to complete 40 clock hours of security officer training from an approved training facility. **There are no provisions for make-up work – DO NOT register for this course unless you can complete all 40-hours of training.**

**APPLICANTS:** Must be at least 18 years of age and have a high school diploma or GED. Must be a citizen or legal resident alien of the United States or have been granted authority to work in this country. Have no disqualifying criminal history. Be of good moral character. Have no disqualifying history of mental illness or alcohol or substance abuse.
